  - c. 116 total ballots submitted representing 58% of the owners. 114 yes and 2 no votes. 20% yes votes were required and met, for approval of the 2022 2023 budget.
- 7. Ballot results for Approval of 2022 2023 Board of Directors
  - a. Five current returning board members. By-Laws allow up to 7 board members
    - i. 2 board positions are open.This is YOUR community. Your help on the board or committees is welcome.
    - ii. OPEN NOMINATIONS for any new Board member nominees. No new nominations were given.
